Information on Fair Housing

The Federal Fair Housing Act, Minnesota Human Rights Act, Minneapolis Civil Rights Act, and the Saint Paul Human Rights Act all prohibit discrimination in housing based on a person's protected class status. This prohibition extends to the rental and sale of housing, advertising of housing, and threats or intimidation. There are a number of resources available throughout the state to assist individuals and families who feel they have been victims of illegal discrimination.
