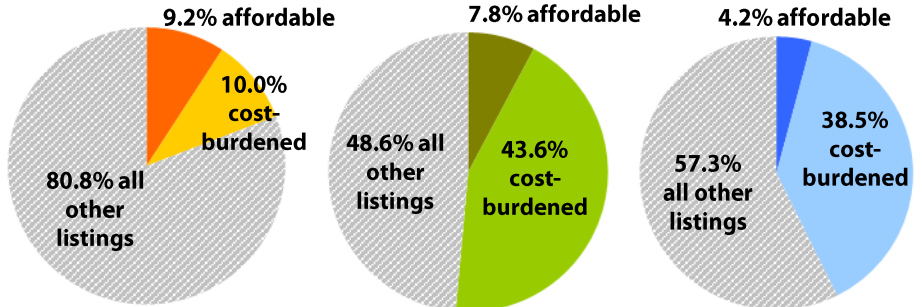

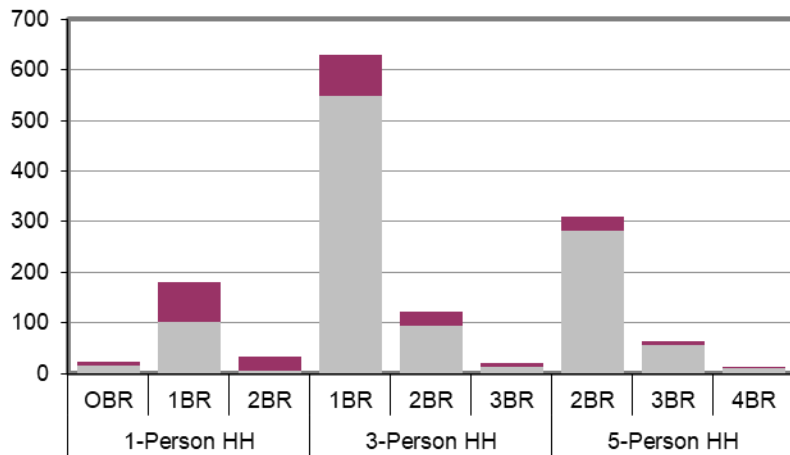

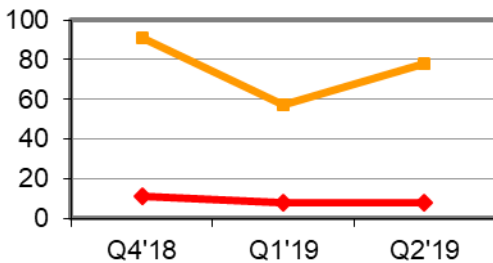
Total Listings by Bedroom Size and Household Type

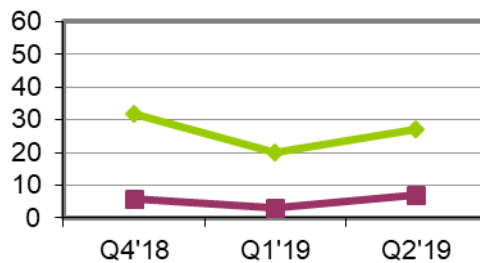
1-Person Household

— 0BR — 1BR



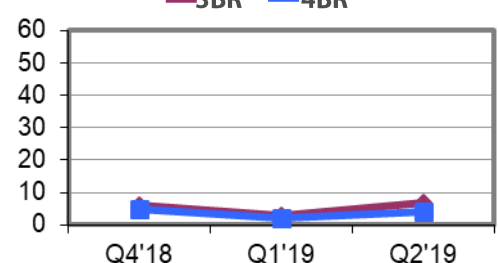
3-Person Household
